



COVID-19 Inequities

Impacts of Limited/No Access to Home Computers & Internet

Michigan State study

•Students who do not have home Internet or only have Internet by cell phone:

oTrail behind peers in digital skills (equivalent to gap between skills of 8th and 11th-grade students).

oHave lower GPAs (averaging ½ a letter grade lower)

oAre less likely to plan to attend college (47% compared to 60% of students with home internet)

Broadband and Student Performance Gaps

Data on Limited/No Access to Home Computers & Internet

Notes from PA data:
Children <u>without</u> high-speed internet at home: oLatino and American Indian: 28%, Black: 26%, White: 16%, Asian: 13% oRural: 26%, "Metro": 17%

 Children without a home computer: oLatino: 21%, American Indian: 18%, Black: 14%, White: 7%, Asian: 6% oRural: 12%, Metro: 8%


Why do we need to detect disproportionality?

Pennsylvania Data -Retrieved from Propublica Database

Non-White Students	33%
Students who received Free/Reduced Lunch	47%
High School Graduation Rate	86%
Opportunity (White students are this likely to be in an AP class compared with Black students)	2.3X
Discipline (Black students are this number of times likely to be suspended compared with White peers)	5.6x
